1. AGENDA ITEM NO. 1: Call to Order

Jeff Branick called the meeting to order at 2:03 PM.

2. AGENDA ITEM NO. 2: Public Comment

The floor was opened for public comment. There were none and the item was closed.

3. AGENDA ITEM NO. 3: Discussion and possible action on nominations for Flood Districts interest category voting member.

The nomination and application of Allen Sims for the vacant Flood Districts interest category was presented to the Group. Robb Starr informed the group of an additional nomination for the Public interest category scheduled to close May 24, 2023. Liv Haselbach motioned to accept the nomination and received a second from Robb Starr for the appointment of Allen Sims as the Flood Districts category representative.

4. Agenda Item NO. 4: Status updates and discussions from RFPG members.

Richard Bagans gave an update for TWDB. The Group was commended on the successful submission of the Neches Regional Flood Plan in May. Subsequently TWDB issued a request for information for clarification and corrections. The information was received and accepted by TWDB and will be presented to TWDB in July for approval before it can be adopted. The amended Regional Flood Plan will follow the same course upon submission in July 2023.

The public comment periods for Rule Changes and Flood Plan Ranking have closed. Comments received are under review and will then be presented to the TWDB for final approval.

An email update will be circulated in the near future detailing next steps for the upcoming second cycle of Regional Flood Planning.

Amended Regional Flood Plan submission guidance was sent out last week. The guidance includes a checklist, and Technical Consultants are encouraged to revisit the requirements since some items were updated.

A reminder that all voting member terms are set to expire July 10, 2023. Voting members will need to draw lots, in accordance with the By-Laws, for a staggered second term of either two or five years.

5. AGENDA ITEM NO. 5: Approve minutes of the April 25, 2023 RFPG meeting.

The meeting minutes were presented for comments. A motion was made by Scott Hall and seconded by Doug Canant to accept the minutes as presented. The item passed with unanimous approval.

6. AGENDA ITEM NO. 6: Receive registered public comments on specific agenda items (limit three minutes per speaker)

There were no registered public comments and the item was closed.

7. AGENDA ITEM NO. 7: Receive update on Texas Department of Transportation projects.

The representative for Texas Department of Transportation, Lisa Collins, answered Group member questions about the steps they are taking as an agency to ensure their projects are not hindering flood mitigation efforts. Funds for drainage projects are available, but not allocated to any particular project at this time. The department will continue to work with the drainage districts to identify crossing projects eligible to receive assistance.

8. AGENDA ITEM NO. 8: Receive update from Gulf Coast Hurricane Protection District.

Allen Sims presented an update from the Gulf Coast Hurricane Protection District. The District met in their regular monthly meeting last week. Currently the focus is the levy in Orange County and the Coastal Spine. Movement has slowed since the project's approval, but once funding is appropriated activity should pick up.

Liv Haselbach motioned to accept the six additional FMEs presented, and the motion was seconded by Doug Canant and unanimously approved by the Planning Group.

Liv Haselbach moved to accept the 21 new FMPs subject to updated information related to the benefit to cost ratios, costs and some modified maps. The motion was seconded by Jeff Branick and approved by all voting members present.
