The Draft RFP is available for review by any interested party until October 09, 2022. The Draft RFP is available online and in four physical locations within the Region. The final RFP is due January 10, 2023.

The Group reviewed and discussed Flood Management Evaluations relating to Flood Mapping Updates (22), Master Drainage Plan(s) (37), Project Planning (90), and Feasibility (7). The Group participated in assigning weights to various factors when selecting FMEs to perform.
