Morgan White, Texas Water Development Board, gave an update regarding the legislature's recent appropriation of additional funding to support the first round of regional flood planning. Approximately \$10 million dollars will be made available September 1, 2021, and will be used to enhance the first set of regional flood plans. TWDB is currently working to process survey responses and develop a methodology to distribute the money among the various regions. TWDB will reach out to RFPG sponsors to coordinate contract amendments.
